## **57 DECLARATION OF INTEREST/CONFLICTS/CONFIDENTIALITY**

There were no declarations of personal interests/conflicts in matters pertaining to the agenda and the confidential nature of proceedings was noted.

## **58 MINUTES**

**AGREED** to approve as an accurate record, the minutes of the meeting of the RCT Pension Board held on 20<sup>th</sup> October 2016.

### **Matters Arising**

- Minute 49 (2) Cashflow Position– Members were advised that this would be considered under the following heading ‘Summary of Action Points Arising from the Meeting of the RCT Pension Board’ held on 20<sup>th</sup> October 2016;
- Minute 51 – All Wales Investment Pooling – It was reported that a joint meeting may be appropriate for members of the Pension Board, Pension Fund Committee and Panel to receive any comments in respect of this issue, furthermore, an update would be provided at the next meeting of the Board;
- Minute 55(1) – Annual Benefit Statements – It was confirmed that an update would be provided at the next appropriate Pension Board where Members would be asked to comment on the new design;
- Minute 55(2) – Guaranteed Minimum Pension (GMP) – Members were advised that this item would be dealt with under Agenda Item 7;

- Minute 55(3) – Annual Allowance/Lifetime Allowance Letters – It was confirmed that the annual allowance letters have been issued to a number of scheme members and the lifetime allowance letters are currently being reviewed before being issued;

**59 SUMMARY OF ACTION POINTS RESULTING FROM THE MEETING OF THE PENSION BOARD HELD ON THE 20<sup>th</sup> OCTOBER 2016**

The Board Members considered each of the action points to have arisen from the previous meeting in turn:-

- Minute 47 – My Pension Online – Members were informed that an update would be provided at the next appropriate meeting of the Pension Board;
- Minute 49(2) – Cashflow Position of the Fund –Members were advised that the Actuary had been commissioned to undertake an analysis. It was confirmed that the position would be regularly monitored and an update provided at the next appropriate meeting of the Pension Board;
- Minute 50(2) – Percentage of the Fund Managed –Information highlighting the value in each fund and the market value of each portfolio was provided by means of a handout circulated at the meeting
- Minute 50(3) – Mandates for Individual Holding Limits – It was confirmed that this information would be prepared for the next appropriate meeting of the Pension Board by means of a table;
- Minute 50(4) – Exit Payment Recovery –In addition to information previously circulated to the Board, a verbal update was provided in respect of Exit Payment Recovery and Exit Payment Caps. It was confirmed that Exit Payments will only apply to Public Sector Bodies , as listed, and regulations are due to be published around September 2017
- Minute 50(6) – Value of CBRE Fund –An update was provided in respect of the breach by CBRE and it was also confirmed that further consideration would be given to the issue later in the meeting under Agenda Item 3;
- Minute 50(7) – Statement of Accounts Link – It was confirmed that the link to the external auditor report had been previously circulated;
- Minute 53 – Update Training Undertaken Item - It was confirmed that the items requested had been added to the list of training undertaken by members of the Pension Board and,
- Minute 55(2) – Guaranteed Minimum Pension (GMP) –It was confirmed that this would be reported under Agenda Item 7.

## **60 INVESTMENT & ADMINISTRATION ADVISORY PANEL**

An update was provided in respect of the minutes of the meeting of the RCT Pension Fund Investment and Administration Advisory Panel held on 30<sup>th</sup> November 2016 and of the Pension Fund Committee held on 18<sup>th</sup> January 2017.

Following consideration of the report it was **RESOLVED**:

1. To note the minutes of the meeting of the RCT Pension Fund Investment and Administration Advisory Panel held on 30<sup>th</sup> November 2016 and the minutes of the Pension Fund Committee held on 18<sup>th</sup> January 2017;
2. That an update in respect of Invesco's performance is provided at the next meeting of the Pension Board;
3. That in addition to the 3 year performance figures a table highlighting the quarter performance figures for all fund managers is provided together with a table demonstrating the total value of the fund analysed by fund manager; and,
4. That all sections of the 'Comments on Monthly Performance' within the Key Service Standards section of the Minutes are completed.

## **61 RISK MONITORING**

The Board was presented with an assessment of the risks associated with the RCT Pension Fund and the control measures in place.

The Board requested clarification in respect of some of the control measures in place particularly in respect of that for the risk under the heading 'Actuarial assumptions are not met' which was duly provided.

The Head of Pensions, Payroll and Payments provided an update in respect of the request from Welsh Government to amend the way in which the closed former Welsh Development Agency (WDA) admitted liabilities are treated. The Board was advised of the outcome of the legal advice sought in this respect.

Following a request for clarification in respect of some of the control measures in place, the Board **AGREED** to note the information provided.

## **62 GOVERNANCE**

### Funding Strategy Statement

The Head of Pensions, Payroll and Payments provided an update in respect of the Funding Strategy Statement (2016 Valuation) which is to be in place by 31<sup>st</sup> March 2017. It was reported that the Strategy had been agreed in principle by the Pension Fund Committee and the Board **AGREED** to note the update.

## Pension Regulator 2016 Survey and Public Service Pension Scheme Self Assessment

Members of the Board were informed that the Pension Regulator Survey is a compulsory survey set out by the Pensions Regulator. Members had before them the survey which had formerly jointly completed by the Chair of the Board and the Head of Pensions, Payroll & Payments and subsequently **AGREED** its contents and that of the Public Service Self Assessment Tool completed by the Chair of the Board.

### **63 MEMBER DATA**

Board Members were provided with an update of detailed actions being progressed in accordance with the Fund's Data Improvement Plan. Following discussion Members **AGREED** the contents of the Improvement Plan subject to a query regarding the timescale of the National Fraud Initiative (NFI) undertaken to identify deceased members quicker to avoid overpayments, which it was confirmed would be responded to in due course.

### **64 GMP RECONCILIATION**

The Board received a verbal update in respect of the GMP Reconciliation in conjunction with additional information which was circulated at the meeting. It was reported that the exercise would need to be completed and returned to the HMRC by 18<sup>th</sup> December 2018.

Following consideration of the report it was **AGREED** that a revised version of the GMP Reconciliation Progress Summary would be circulated following the meeting.

### **65 KNOWLEDGE AND UNDERSTANDING FRAMEWORK**

Officers provided the Board with a copy of the 'Knowledge and Skills Framework' showing details of the Core Technical Requirements for the Chair and Members of the Pensions Fund Board together with details of the training undertaken to date.

It was confirmed that the training schedule would be updated to include the following:-

- Board Member A. Pring attended the TUC Conference on the 1<sup>st</sup> February 2017 (A summary and verbal update was provided to other Board Members at the meeting);
- Board Member A. Pring attended the Additional Voluntary Contribution Pension Seminar on 25<sup>th</sup> January 2017 in the County Borough Council Offices, Bronwydd and,
- Board Member H. Coombs completed the Pension Regulator 2016 Survey and the Pension Regulator Public Service Self Assessment Tool.

In addition, it was **AGREED** that a factsheet explaining the 85 Year Rule would be circulated following the meeting.

## **66 OTHER BUSINESS**

It was announced that this would be the last Pension Board that Mr G. Williams would attend in his capacity as Employer Representative (South Wales Police) as he would be shortly retiring from his position with South Wales Police. On behalf of the Board, the Chair wished Mr Williams the very best of luck with his retirement and thanked him for his contribution to the RCT Pension Board since its inception.

It was confirmed that a succession plan would be discussed with the Chair of the Board and appropriate arrangements implemented in due course.
